Compliance with Laws and Regulations:

Freely Chosen Employment:

Suppliers must ensure that all employees work voluntarily and without any form of forced labour, slavery, or human trafficking. Suppliers must comply with all applicable laws and regulations regarding employment practices, including minimum age requirements and laws related to the prevention of forced labour.

Work Hours and Conditions:

Suppliers should provide their employees with safe, healthy, and fair working conditions. Working hours must comply with national laws, industry standards, and applicable collective bargaining agreements. Employees should be provided with reasonable working hours, breaks, and days off. Suppliers must establish mechanisms for employees to voice their concerns and protect them against discrimination or harassment.

Health and Safety:
